Nutrient Mitigation Strategy

Background

There is existing evidence of high levels of nutrients in the water environment with evidence of eutrophication at some designated sites. As such, there is considered to be a likely significant effect from residential (and similar) developments located within the New Forest National Park. As a result, an avoidance and mitigation package will be needed in order for the Authority to lawfully grant planning permission for such development.
